Phase II Non-Universal Distribution



This distribution could be considered a flaw in <u>land-based capitalism</u> distribution theory, since it is not distributed equally to all. After <u>federation</u>, the distribution will mostly be associated with age and total disability.

Other uses include distribution during hospitalization and incarceration (to the institution, not the <u>Earth Dividend</u>

holder). After release from the hospital or penitentiary, the non-universal distribution pays a <u>wellness annuity</u> and <u>no-recidivism annuity</u>.

These payments go to the institution, not the dividend holder. Because most <u>legacy governments</u> have age and disability-related benefits, the non-universal distribution in <u>Phase II</u> only pays the \$25/month wellness annuity and \$25/month no-recidivism annuity.

Wellness Annuity



The wellness annuity is in addition to the healthcare distribution. The hospital, voluntary rehab, or mental health facility need not be a participating self-insured HMO (<u>SIHMO</u>). Whenever a person spends at least one night in any of these facilities, the institution will receive \$25/month until the patient passes away or again

spends at least one night in such a facility.

This will dramatically lower the cost of a night in a hospital. Although hospitals and rehabilitation facilities do not need to be affiliated with an SIHMO to qualify, other charges require an approved diagnosis and prognosis. The patient's SIHMO will pay the hospital 95% of their charge-list rate for the hospital bed, procedures, surgeries and tests, provided the patient was diagnosed at the SIHMO or the outside diagnosis is unchallenged. Otherwise, only the \$25/month wellness annuity is paid to the hospital directly from the Earth Dividend.

The SIHMO charge-list rate for a night in the hospital or rehab will be low, such as \$100 (2022 dollars), or perhaps even free. Facilities also receive the food distribution per diem from the next month's distribution, and have access to the housing distribution for stays beyond a month. The wellness annuity provides incentive to hospitalize patients incapacitated for a day or two with the flu.

No-Recidivism Annuity



The \$25/month no-recidivism annuity is paid to jails and prisons, once a sentenced prisoner has served their time. It is paid until an ex-prisoner is sentenced for another offense and can never be initiated twice to the same institution.

Qualifying offenses in <u>Phase II</u> are <u>class I</u> violations of <u>objective rights</u>. Thus, child abandonment, drug law violations, gun law violations, practicing a trade

without a license, assisted suicide, and other <u>class II</u> violations are crimes where the no-recidivism annuity will not be granted. Neither do they nullify an earlier awarding of the annuity.

Institutions have an incentive to help the released prisoner reintegrate into society. That incentive is \$25/month until the released prisoner passes away, if there is no recidivism.
