Summary of the Vision

After the revolution, comrade, you shall have your utopia

Vote for me and I'll set you free

If everybody thought like me, the world would be a perfect place

The vision of <u>AFFEERCE</u> is not conditioned on such nonsense. It is a <u>business plan</u> to bring about a better world, motivated by profit and wins for all involved.

With AFFEERCE, much of the vision is achieved before <u>federation</u>. A large portion of the world's land will be pulled into the <u>commons trust</u>, by well-understood economic forces, long before the first <u>constitution</u> is ratified.

Land will be available to <u>the most efficient user</u>. The vast majority of land will be free. Any person or group can grab some free land and start a business, a community, or even lay the foundation for something larger. Megacities, there will be!

From the very start of <u>Phase I</u>, all the economic dynamics favor <u>the creation of</u> <u>megacities</u>. Some say this is enough, enough to revolutionize the world, end poverty, and give everyone a level playing field to start. But we are just getting started.

AFFEERCE liberates land under <u>legacy governments</u>. But it does so much more. No change in government is needed to provide many people all over the world with an <u>Earth Dividend</u>; nutritious meals, warm and safe shelter, quality healthcare, and unlimited free education. The dividend also pays for a person's police and fire protection, sanitation, a government to protect their rights, transaction fee-free commerce, <u>and more</u>.

This miracle of economics is a natural outcome of the business plan. However, after fifteen or twenty years, it kicks into overdrive with <u>VIP\$ deflation</u>. People will do whatever it takes to get hold of a VIP\$, their ticket to an early Earth Dividend. What it takes is the productive capacity to service the Earth Dividend.

The reallocation of productive resources from luxury goods to ordinary goods will allow us to achieve this objective without any change in government. At this point, the world finds itself in <u>a political stalemate called dual power</u>. Cellular democratic "governments" were formed in order to distribute the Earth Dividend for public goods and services.

Meanwhile, the <u>legacy government</u> is still taxing people (and/or <u>getting 30% of the</u> <u>ground rent</u>) to fund public goods and services. Certainly, a great time to be a public servant with all that money floating about.

<u>Federation</u> is almost an afterthought. It is made inevitable by a shortage of VIP\$. There is simply not enough <u>land value in the world</u> (\$217 trillion) to fund the present value of an Earth Dividend for everyone in the world (8 billion x \$250,000 = \$2 quadrillion).

<u>Sequestration of VIP</u>^{\$} in the <u>Present Value Fund</u> in conjunction with auctions for the Earth Dividend will create <u>hyperdeflation of the VIP</u>^{\$}. This is equivalent to <u>hyperinflation of all fiat currencies</u>.

Here are the three monumental consequences of VIP\$ hyperdeflation:

- Hyperdeflation reallocates resources to service the Earth Dividend, significantly lowering the present value in VIP\$ required to fund an Earth Dividend, so everyone in the world can be awarded an Earth Dividend.
- Hyperdeflation pulls all the remaining private land into the <u>commons trust</u> as desperate governments sell their national parks and other government land to raise much needed VIP\$ (<u>cellular governments</u> will probably agree to respect national park and wetland covenants of the legacy governments).
- 3. Finally, hyperdeflation allows for federation, where <u>fiat currency</u> of the federating government can be exchanged for VIP\$ at the <u>natural exchange</u> <u>rate</u>; which is unfavorable, but at least there is an exchange rate. Federation requires constitutional amendments approved twice, first by the legacy government according to its practices, and then by the <u>direct democracy</u> of the <u>cellular dominions</u>.

Economic reality prevents an optimal transition; first, all the land is purchased into the commons trust, then everyone in the world gets an Earth Dividend, then there is federation. In reality, perhaps a third of the world's land will be purchased into the <u>commons trust</u>, and 5% of the world's population will get the Earth Dividend.

Ultimately, <u>deflation</u> will become <u>hyperdeflation</u>, and the rest will happen quickly.

The <u>ABC</u> and <u>VIP Treasury</u> are perhaps the first revolutionary organization in history the goal of which is not to speed up the time to revolution, but slow things down!

A lengthy period before hyperdeflation kicks in allows more productive resources to be allocated by the market into servicing the <u>Earth Dividend</u>. It allows more people to become comfortable with and confident in a <u>cellular democracy</u>. It gives legacy governments a chance to pay off their debt with inflated fiat currency.

The Earth Dividend and <u>Freedom Tax</u> give legacy governments a chance to reduce the general tax burden. Time allows for an attrition plan and transition plan for legacy government employees.

The Vision Post-Federation

AFFEERCE can liberate land and end poverty before federation. But only federation can end the devastating <u>intellectual property</u> monopolies that haunt us through <u>Phase I</u> and <u>Phase II</u>. Only with <u>federation</u> is content liberated along with land.

The liberation of land, the liberation of content, and the Earth Dividend will not only have <u>an explosive effect on productivity</u>, but will profoundly alter the culture as well.

The most noticeable change to daily lives will be how people voluntarily organize themselves into families and enterprises. Mixed-use habitats, large families, and collectives are favored by economies of scale and new divisions of labor.

<u>Free Enterprise</u> will flourish as government-imposed taxation is abolished and only <u>a single regulation</u> for adults remains. The people, not legislators or the judiciary, will have <u>the power by a 2/3 plurality</u> to enact certain kinds of taxes and put a halt to negative externalities.

The large one-year advance rent fund is available to small businesses and collectives through <u>Citizen Investors</u>. <u>VIP Enforced Budgets</u> that disallow salary and services make these loans extremely safe and give collectives and small businesses a material advantage over legacy corporations.

<u>The VIP Environment</u>, which served humanity so well as early as <u>Phase I</u>, continues to evolve as a hub of funds, information, communication, applications, storage, and transactions.

Every person is valuable in the financial as well as the spiritual sense. When a person becomes part of a family or collective, they bring with them their food and housing distribution. Whatever labor they contribute benefits the group inasmuch as subsistence is covered by the Earth Dividend.

When a person moves to a community, they increase funding for police and fire protection, streets, sanitation, and local government. It heralds the end of involuntary loneliness. Refugees are welcome everywhere.

The <u>direct democracy</u> plays a dual role as level 1 of the <u>cellular democracy</u>. These same individuals, as a court of the people, play a dual role as level 1 of the <u>judiciary</u>. The cellular democracy is structured to remove any impediments to bargaining (<u>the normative Coase theorem</u>).

The role of the cellular democracy in protecting <u>objective rights</u> and the role of the <u>direct democracy</u> in <u>overriding objective rights by a 2/3 plurality</u> to implement their <u>reasonable subjective desires</u> ends the stalemate that today polarizes communities around the world.

Even objective rights that cause no reasonable externality <u>can be overridden by a</u> <u>5/6 plurality</u> with the <u>right of "no" voters to leave the dominion and be richly</u> <u>compensated for their property</u>. <u>Sovereignty</u> itself can be created with the same plurality.

The only constitutional caveats are absolute <u>exit rights</u> for those adults who surrender their individual sovereignty to a sovereign dominion, the <u>right to life for</u> <u>their children</u>, and peaceful surrender to the <u>dominion treble</u> of <u>outside forces</u>. Should a larger sovereignty fail to abide by these constitutional provisions, the <u>Federation Military</u> will intervene.

Between the vast diversity of communities, the Earth dividend, and the welcoming of people everywhere, voting with one's feet, the first historical validation of <u>the</u> <u>Tiebout Hypothesis</u> becomes universal reality.

Although it is impossible to end crime and corruption altogether, there are <u>objective reasons why these will be reduced by 80% or more</u>. The VIP allows for <u>many innovations in law enforcement that aid in crime reduction</u>.

Penitentiaries are rewarded for <u>non-recidivism</u>, and hospitals are rewarded for <u>wellness</u>. Healthcare is revolutionized with the <u>Self Insured HMOs</u>, and <u>education</u> <u>is revolutionized</u> with backpack funding and merit.

The fertility crisis in today's industrialized world, where few can afford a child and many would not even wish to bring a child into a world of hopelessness, is broken by AFFEERCE. The Earth Dividend gives all children nutritious meals, warm and safe shelter, quality healthcare, and unlimited free education throughout their lives.

Collectives and large families provide nurturing child care environments. It is a world where people are limited only by their ability. The reasons for most abortions will disappear with the demand to adopt far exceeding the supply.

People will be so fruitful, any problems will be in the other direction, particularly sovereignties that turn women into baby machines. If fertility gets too high, we might need to address the tragedy of the commons and implement <u>the baby tax</u>.

Perhaps the most important AFFEERCE contribution is to the survival of the Earth. In <u>Phase I</u> we offer <u>"air rights" trebling</u> as a free service to the world. With federation, that expands to timber rights, fishing rights, and trebling for rights to other natural resources.

With <u>intellectual property</u> royalties paid based on distribution, widely distributed inventions that clean the air and water will pay big royalties even without sales potential. There is the ability of the direct democracy to stop externalities by a 2/3 plurality without corrupt regulations and loopholes.

The rise of mixed-use collectives ends some of the pollution and congestion from transportation. The Earth dividend ensures nobody needs a polluting, unhealthy job to survive. Disaster can still happen, but <u>no political or economic system is</u> <u>better suited to handle cataclysm</u>.

This new epoch in humanity is hypothesized to be part of a broader philosophical and cultural change in humanity – the withering away of racism, classism, sexism and the other isms. It will mark the end of postmodernism and the recognition of truth in nature.
